# Grievance Committee Update By Dawson McDermott

Greetings, fellow bargaining unit members (aka known as BUMs). The fall semester is upon us and another year has gone by. For those of you who don't know me I am Dawson McDermott. I am the chairperson for your Grievance Team. I have been on the team since fall of 2003 and became the chair in December of the same year. I also serve on the Negotiations Team as well for the two contracts and the current one in negotiations. I would like to take a bit of your time to explain my role and introduce to you the Grievance Team. I appreciate your sticking around.

One role of the Grievance Team is to basically enforce the contract in situations where there may violations of the collective bargaining agreement (CBA). Article 15 is the article that allows for the filing of grievances. You may be asking yourself, "what is a grievance?" As it pertains to our CBA, it is an event/situation/etc. that is a misapplication, misinterpretation, or discriminatory application of a specific term, condition, or provision of the CBA. Lots of big, vague words.

A second role of the Grievance Team is to represent you if you are directed to meet with the Administration regarding an issue. Bargaining unit members have the right to request representation from the PA. The administration typically is good about informing a bargaining unit member of this right. But when in doubt feel free to request representation.

A third role of the Grievance Team (typically the chairperson) is to be on the Negotiations Team. Grievance team members typically have lots of experience using the CBA so language that is negotiated needs careful review, history of language, etc. to move forward in settling negotiations. Some of the arbitration history is important in framing language, understanding issues, and avoiding possible future abuses in proposed language.

The best advice I can give regarding whether a situation is a grievance or if you have a question about the contract is to speak to a member of the grievance committee. Grievances tend to be situational and in some instances, management may be within their right regarding some action/event. The decision to grieve requires research, discussion, etc. among the team, our NYSUT representative (our Labor Relations Specialist is Jim Henck), and President. There is a long rich history with the PA and the Administration so being aware of the history, the CBA, and application of both is critical. As a bargaining unit member you have the right to ask any member of this team about a situation and your rights within the CBA. ALWAYS exercise that right when in doubt.

# 44th Annual NYSUT Representative Assembly April 8-9 2016, Rochester, NY **By Jim Roberts, 2nd VP**



P.A. President Norma Chrisman, Political Outreach Chair, Justin Rahn, and I attended the 44<sup>th</sup> Annual Representative Assembly in Rochester, in April. Perhaps the biggest news item to come out of the weekend was presidential nominee, Hillary Clinton's surprise appearance at the assembly Saturday night.

Due to Clinton's appearance, committee work was rushed Friday afternoon to accommodate the lengthy TSA-style security checkpoints all delegates had to pass through before entering the conference center. Nevertheless, more than thirty resolutions were passed ranging from educational issues, workplace safety, and collective bargaining rights.

The primary focus of the Legislative/Political and Educational Issues Committees was, of course, high-stakes testing, APPR, and receivership in K-12. NYSUT continues to oppose the overt dismantling and privatization of public schools.

I was particularly impressed by the members of the "Stronger Together Caucus" who spoke out strongly against the "data-obsessed, test-driven education reform." You can visit their website: http:// stcaucus.weebly.com/.

### National Labor Relations Board rules graduate assistants at private universities may legally form unions
