



Executive Board approves MVCCPA Bylaw changes

Members will vote at April 29 meeting

At its meeting on March 27, 2025, the MVCCPA Executive Board approved changes to

the MVCCPA Bylaws. The membership will be asked to vote upon the changes outlined below at the General Membership meeting on Tuesday, April 29, 2025, at 4:30 p.m. in Payne Hall room 102 at the Utica Campus.

ARTICLE IV. QUALIFICATIONS AND DUTIES OF OFFICERS

Section 4. The Secretary shall:

- Record, maintain, and distribute accurate and up-to-date minutes of General Membership Meetings, Special Meetings, and **Executive Board Meetings.**
- Bring such minutes of the current fiscal year to meetings.
- Assist with any correspondence to the membership or others as needed.

- Serve as the custodian of Association records as directed by the Executive Board.
- Serve as an ex-officio member of Chair the Research and Records Committee.

ARTICLE V. STANDING COMMITTEES

Section 3. The Political **Outreach Committee shall:**

- Be composed of eight voting members of the Association. Four members shall be elected by the voting membership and four members shall be appointed by the Executive Board. The chair shall be elected by and from the membership of the committee on or before June 5.
- Be composed of eight voting members of the Association.

2 students win 2025 MVCCPA **Scholarships**

MVCC students Gustavo Nunes and Isaiah Sobolewski have been named the 2025 recipients of the MVCCPA Scholarship. This annual \$1,000 award recognizes outstanding students currently enrolled at MVCC who demonstrate academic excellence, leadership, and community involvement. The scholarships were presented during the PA Luncheon held on Jan. 17, 2025.

Gustavo Nunes, an international student from Belo Horizonte, Brazil, has excelled academically and athletically during his time at MVCC. A Business Administration and Accounting major, he has maintained a GPA above 3.0 while balancing multiple responsibilities. He serves as captain of the Men's Soccer Team, works part-time as a Student Assistant in the Admissions Office, and is an active campus leader. Gustavo has earned recognition on the Vice President's List and was named to the All-Conference Team after helping lead the MVCC Men's Soccer Team to victory at the NJCAA National Championship in Fall 2024. A dedicated volunteer, he also supports local food distribution initiatives. He is on track to graduate from MVCC in May 2025 and plans to continue both his academic and athletic pursuits at a fouryear college or university.

Isaiah Sobolewski, a Nutrition and Dietetics major from New York Mills, N.Y., has maintained a perfect 4.0 GPA since beginning MVCC classes as a dual credit student in 2020. He has consistently earned a place on the President's List and was honored as a member of the 2023– 2024 NJCAA All-Academic First Team for Men's Track & Field. In addition to these achievements.

Isaiah works two part-time jobs and is active in community service — tutoring younger students in math and participating in Earth Day events and community clean-ups. He plans to transfer to Utica University in the fall.

To qualify for the PA Scholarship, a student must have completed at least 30 credit hours at MVCC and have a GPA of at least 3.00. Applicants also must write and submit a 500-word essay on the importance of labor unions in American society or the value of a community college education. The Value of Community College

An excellent option for higher education are community colleges, offering a pathway to affordable, accessible, and good quality learning opportunities. They provided much more than just study, bringing benefits not only to the students but also to the community. A community college education can be transformative, equipping students with skills for career success, fostering personal growth, and contributing to the community at large.

One of the main advantages of community colleges is the accessibility. Unlike traditional four-year institutions, community colleges often have open admissions policies, one example at MVCC they don't have application fees and accept GED diplomas, making them an excellent option for individuals who need a fresh academic start or are returning to education after time away. With tuition costs significantly lower, community colleges provide a financially viable option for students. Being able to take classes and transfer credits to other schools saves a lot of money while getting a quality education that is useful for progressing after graduation. In addition, it makes it easier for international students from countries where the exchange rate is not good to study abroad, allowing them to have an international degree and an introduction to a new language and culture.

Community colleges can serve as a good first step for students aiming to earn a bachelor's degree. Students can complete their general education requirements at a fraction of the cost before transferring to complete their degree. Having good advisement is essential to make the best plan for each student. This ensures that credits earned at a community college are accepted by other institutions, streamlining the transition process. This pathway not only reduces the financial cost for students but also

helps them build confidence in their academic abilities before taking on the challenges of a bigger university. Many community college students graduate from universities with minimal debt, giving them a head start in their careers without the financial stress of significant loans.

Community colleges have tremendous importance in offering career-focused programs that align with local workforce needs. Fields like healthcare, technology and business are greatly benefited by the generation of well-qualified and prepared people by community colleges. Some programs often provide hands-on training, certifications, and mainly associate degrees that prepare students to enter the workforce quickly and competently. Community colleges are also hubs for workforce development. They collaborate with local industries to design programs that address current and future job market demands.

Community colleges are also very flexible. Many offer evening, and online classes, helping students to balance education with work, family, or other responsibilities. In addition to academic flexibility, community colleges provide a huge support service. From tutoring and counseling to career guidance and financial aid assistance, at MVCC for example there are all these resources on campus to help students navigate challenges and achieve their goals.

The benefits of community colleges extend beyond individual students to the whole community. Community colleges also offer noncredit courses, workshops, and cultural events, enriching the lives of local residents.

The value of a community college education lies in the ability to provide affordable, accessible, and career-oriented learning opportunities while supporting diverse student needs.
